- This facility is open for use for NOC shoe tag holders from dawn until dusk daily:
 - a. except Mondays and Thursdays from 6:00 pm to 8:00 pm and Saturdays from 10:00 am to 12:00 pm (NOC training times)
 - b. except where booked for track meets
- Rules of use as posted on the signs at the entry gates must be adhered to.
 - No cluster spikes, motorized vehicles, in-line skating, roller skating, skateboarding, cycling or pets.
 - Track spikes maximum length - 5 mm
 - Runners - use only inside lanes 1-4; Walkers - use outside lanes 5-8
- The Training Permit is designed for training teams, not as a permit for classroom or whole school use. Groups wishing to book the park for meets must apply for a day use permit.
- Participants wishing to train on their own time must purchase a shoe tag (\$30.00). Forms on NOC website.
- Permit will be sent to the applicant after receipt of signed application, insurance certificate and payment.

TERMS AND CONDITIONS FOR FACILITY RENTAL PERMIT 2011 - 2012

The Lessee agrees to the following:

1. An applicant must be 18 years of age or older to lease the facility. The applicant must be present at the event and carry with them the permit and applicable certificate of insurance.
2. NOC reserves the right to cancel or alter a contract or any part thereof, at any time and shall make every effort to give adequate notice to the Lessee. NOC shall not incur any liability in the event the facilities are not available for any reason.
3. A permit is not transferrable. Any changes must be approved, in writing, by the Facilities Coordinator.
4. The Lessee shall carry liability insurance of at least \$2 million and name Niagara Olympic Club as an Additional Insured.
5. The Lessee releases and forever discharges NOC from any and all actions, causes of action, claims, and demands for damages, loss or injury, however arising, which may be sustained by the lessee in consequence of entering and using the facility.
6. It is understood and agree, the Lessee assumes full responsibility for the proper supervision of any activities they conduct on the premises, and for any damage caused to the premises.
7. **ALCOHOL IS STRICTLY PROHIBITED ON THE PROPERTY.**
8. **SMOKING IS STRICTLY PROHIBITED ON THE PROPERTY.**
9. It is the responsibility of the Lessee to ensure that the property is clean after use.
10. NOC, or those agents authorized by NOC, shall have the sole and exclusive rights and control over all food and beverage services/concessions.
